# 24th National Juried Art Exhibition

## JUROR:

Dr. Lee A. Ransaw, a graduate of Indiana University in Bloomington, Indiana, served as Dean of Arts & Letters, Professor, and Chair of the Art Department at Morris Brown College in Atlanta, Georgia for more than 20 years. He is now President of the National Alliance of Artists from Historically Black Colleges and Universities. He also serves as adjunct professor of Art Education at Spelman College in Atlanta, Georgia. His work is in many private collections and has been shown nationally at major museums and galleries. "My works on canvas are occasionally abstract but generally figurative images, with mixed media and acrylics being the preferred media. I like the richness and luminous effect that one gets by expanding the human figure with layers of materials as well as the quick way I can work on a series of ideas on one or more canvases at the same time. Most of my ideas for subject matter for my larger works have come from study of abstract expressionism in art history and my ties to a Southern Heritage".

## ELIGIBILITY:

Open to all residents of the USA. Submit only work completed within the last three years. All works submitted must be original works of the applicant and must not have been accepted in prior juried exhibitions of the SCAA. No reproductions or copies will be accepted.

## CATEGORIES OF ELIGIBILITY INCLUDE:

Painting- Oil/Acrylic; Painting - Watercolor; Pastel; Printmaking - etching, woodcuts, serigraphs, etc; Drawing; Sculpture - metal, clay, wood or any mixture in 3-D form; Photography; Mixed Media (list all materials used); Fine Crafts and Collage.

## CALENDAR 2011

June 8.....Last accepted postmark date for entry form, CD and entry fee.  
July 9.....Juror's notification mailed.  
August 16.....Deadline for all shipped works to arrive at shipping agent.  
August 17 & 18.....Receive dates for all hand-delivered work.  
August 20.....Awards Reception: 5pm - 7pm.  
October 3.....Exhibition closes.  
October 4 & 5.....Pick up hand-delivered work.  
October 5.....Shipped work returned.

## LIABILITY:

The SCAA, Inc. has an excellent security system within the Mable House Art Center. However, neither the SCAA, Cobb County Board of Commissioners nor any organization affiliated with the Mable House Art Center will assume responsibility for lost, damaged, or stolen items. Insurance is the responsibility of the artist.

## SIZE LIMITATIONS AND FRAMING:

Size limitations for all 2-D work should be no larger than 48" x 48" including frame. 3-D work should not exceed 45 lbs. or 60" in any direction. (If work exceeds these limitations, call 770-819-3285 before submission). Three-dimensional work over 25 lbs. must be hand delivered and picked up by the artist. Two-dimensional work must be framed, ready for hanging with wire in place. Work not properly framed will be disqualified. All shipped work must use Plexiglas – no glass. The committee reserves the right to reject artwork not deemed suitable for this venue.

## APPLICATIONS:

Each applicant may submit 1-3 entries on a CD along with a non-refundable entry fee of \$30, made payable to SCAA. Images on CD must be at least 300dpi and sized 5 x 6 inches or larger and saved as JPEG files. Each CD must be labeled with the artist's name, title of work, medium, size, and an arrow indicating the top of the artwork and the number that corresponds to the entry form and artwork labels. Complete your CD first.

## ENTRY FORM:

Return completed application, CD and entry fee. The image order listed on the entry form needs to match the image order on the CD.

Include a self-addressed, stamped acknowledgment-of-receipt postcard, if so desired. Please retain artwork labels to attach to the back of accepted artwork.

## CATALOG AND WEBSITE:

An exhibition catalog will be produced and will be given to each accepted artist. Additional catalogs will be available for a mailing and handling charge of \$3.00 each. Images of award winners will be placed on our website: [www.southcobarts.org](http://www.southcobarts.org).

***PLEASE NOTE: For the purposes of publicity or for inclusion in the exhibition catalog or website, images of accepted artworks may be used unless the artist requests otherwise in writing.***

## SALES AND PURCHASE AWARDS:

### Regular Sales

Sales are encouraged. Any regular sale will be the sales amount the artist has requested. A 25% commission will be withheld. The South Cobb Arts Alliance will pay the sales tax.

### Purchase Awards

Sales are encouraged. Supporters (patrons) of the National Show guarantee to purchase a piece of art through the Purchase Award program. The supporters (patrons) pledge amounts of \$100, \$250 or \$400 in advance of the show. If an artist is interested in participating in this program, the artist does so by indicating on the entry form which art piece is available for sale in the Purchase Award category and checking the amount level that the artist is willing to sell that piece. No commissions are withheld from the Purchase Award sale; however, a 6% sales tax is withheld from the amount the artist is paid.

## SHIPPING AND HANDLING:

Shipped artwork must be sent to the designated shipping agent: Pak Mail Center #430, 1860 Sandy Plains Rd. Ste. 204, Marietta, GA 30066, 770-321-8262. A check made payable to Pak Mail Center #430 for storage and delivery to and from the exhibition venue, must accompany the artwork: \$35.00 for one piece of artwork; \$45.00 for two or more pieces of artwork. If artwork is shipped in a wooden crate with screws, please include an additional \$5.00 handling fee. There is no handling fee for artwork hand-delivered by the artist to the venue. Pak Mail will retain the original packaging and use it for return shipping of the artwork to the artist. The return shipping of the artwork will be handled by Pak Mail. Accepted artists will receive return shipping information within 10 days after receipt of the artwork at the Pak Mail facility. For artists shipping through Pak Mail there is no repackaging fee. However there is an additional \$10.00 repackaging fee for artists using their own shipping accounts and this fee must be included in the check for the storage and delivery fee referenced above. If Pak Mail does not receive a check for return shipping, artwork will be returned C.O.D. via courier. Pak Mail will not be responsible for artwork left at its facility longer than 30 days after the close of the exhibition. 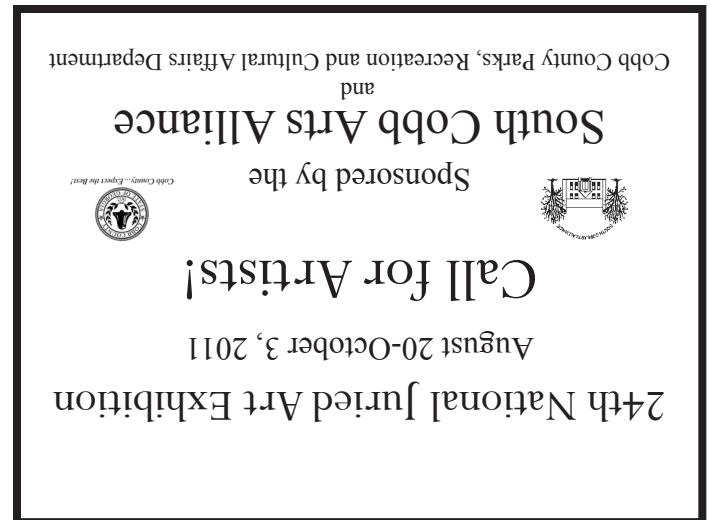
